On October 5, 2015, TransCanada Keystone Pipeline L.P. ("TransCanada") of Houston, Texas, filed an application with the Nebraska Public Service Commission ("Commission") seeking approval of a route for the Keystone XL Pipeline Project through the State of Nebraska. Several petitions for formal intervention were timely received and granted.

On November 18, 2015, TransCanada filed a Motion to Dismiss its Application without Prejudice and requesting the Commission dismiss its application for approval of a route for the Keystone XL Pipeline Project.

In light of TransCanada's Motion, I find that the Planning Conference previously scheduled for Thursday, November 19, 2015, at 10:00 a.m. CST, should be cancelled.
